



#### Investment Strategy

DWAW is an actively managed global strategy 18,000 that provides an objective rules-based approach to "go anywhere" equity investing. Using Nasdaq Dorsey Wright's relative strength-based Fund 14,000 Score Method framework DWAW tactically allocates its portfolio to only the highest ranked securities in its investment universe and may include exposure to domestic international or emerging markets; small mid or large caps; growth or value styles; factor- or market-based weights; or even cash. DWAW seeks to identify and benefit from changing leadership themes in the market.

The MSCI All Cap World Index is an unmanaged free float-adjusted market capitalization weighted index that is designed to measure the equity market performance of developed and emerging markets. One cannot invest directly in an index. Large-growth funds invest in stocks of big U.S. companies that are projected to grow faster than other large-cap stocks. Stocks in the top 70% of the capitalization of the U.S. equity market are defined as large-cap. Alpha measures the risk-adjusted premium an investment earns above its benchmark. Beta measures the volatility of a security or a portfolio in comparison to the entire market. Standard Deviation measures the dispersion of a set of data from its mean and is calculated as the square root of variance. Information Ratio measures the active return of the manager's portfolio divided by the amount of risk that the manager takes relative to the benchmark. Sortino Ratio measures the excess return over the risk-free rate divided by the downside semi-variance, and so it measures the return to "bad" volatility. Sharpe Ratio measures the average return minus the risk-free return divided by the standard deviation of return on an investment. Down Capture Ratio measures an investment manager's overall performance in down-markets. Correlation measures how two securities move in relation to each other. Tracking Error measures how closely a portfolio follows the index to which it is benchmarked. R2 measures the percentage of a fund or security's movements that can be explained by movements in a benchmark index.
