

DWUS is an actively managed, targeted U.S. Core 20,000 market strategy applying a technical, systematically driven process to answer the question - "What part of the U.S. Large Cap equity market should be 16,000 owned?" Using Nasdaq Dorsey Wright's Fund Score 14 000 Method framework, DWUS allocates its portfolio to the domestic large cap funds in its U.S. Core investment universe that demonstrate the 10,000 highestranked relative strength, regularly reassessing and reallocating its holdings.
