

Investment Strategy

VEGA is a low volatility, moderate risk global balanced portfolio that strategically allocates 25,000 to the capital markets, tactically weights regions, sectors, or securities and then 20,000 employs option strategies seeking to create additional sources of income and enhancements to risk management. Over the long term, the portfolio manager strives to manage the portfolio to a beta of 0.65 of the 5,000 S&P 500. VEGA can serve as a core holding or as an alternatives sleeve within a portfolio.

The S&P 500 Index is a broad-based, unmanaged measurement of changes in stock market conditions based on the average of 500 widely held common stocks. The MSCI AC World Index is an unmanaged free floatadjusted market capitalization weighted index that is designed to measure the equity market performance of developed and emerging markets. Sortino Ratio measures the excess return over the risk-free rate divided by the downside semi-variance, and so it measures the return to "bad" volatility. Sharpe Ratio measures the average return minus the risk-free return divided by the standard deviation of return on an investment. Down Capture Ratio measures an investment manager's overall performance in down-markets. Correlation measures how two securities move in relation to each other. Tracking Error measures how closely a portfolio follows the index to which it is benchmarked. R2 measures the percentage of a fund or security's movements that can be explained by movements in a benchmark index.
