



## AdvisorShares 2015 Qualified Interest Income ("QII") Report for Non-Resident Alien ("NRA") Shareholders

Non-Resident Alien ("NRA") shareholders are normally subject to a 30% (or lower tax treaty rate depending on the country) NRA withholding tax on ETF dividend income and short-term capital gain dividends, unless such dividends are designated as exempt from NRA withholding tax.
