







Investment Strategy

QPX is an actively managed ETF seeking long-term Time Per growth by targeting equity market upside while managing downside risk during abnormal market volatility. Using ETFs, QPX may invest in a broad variety of equities across market cap, style or sectors and can use various fixed income categories and commodities to manage risk. QPX applies Q Methodology's proprietary risk management strategy to optimally allocate the fund's assets against a given level of risk. Normally, QPX invests primarily in equity ETFs to provide broadmarket equity like returns. When market volatility is high, QPX can tactically allocate to a more defensive portfolio and seek short-term fixed income returns.

The Morningstar Rating™ for funds or "star rating" is calculated for managed products with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive five stars the next 22.5% receive four stars the next 35% receive three stars the next 22.5% receive two stars and the bottom 10% receive one star. The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its three- and five-year Morningstar Rating metrics. The weights are: 100% three-year rating for 36-59 months of total returns 60% five-year rating/40% three year rating for 60-119 months of total returns.

The S&P 500 Index is a road-based, unmanaged measurement of changes in stock market conditions based on the average of 500 widely held common stocks. One cannot invest directly in an index. Large-growth portfolios invest primarily in big U.S. companies that are projected to grow faster than other large-cap stocks. Sortino Ratio measures the excess return over the risk-free rate divided y the downside semi-variance, and so it measures the return to "bad" volatility. Sharpe Ratio measures the average return minus the risk-free return divided y the standard deviation of return on an investment. Down Capture Ratio measures an investment manager's overall performance in down-markets. Correlation measures how two securities move in relation to be explained by movements in a benchmark index.
